General Terms & Conditions (GTC) for Events

Cancellation - Cancellation of the participant

Cancellations can only be made in writing. Should a participant be prevented from attending, the appointment and participation of a substitute who fulfills the corresponding participation requirements for the event is possible after consultation with the organizer without cancellation fees.

In case of cancellation or rebooking of the participation by the participant, the following cancellation fees will be charged by Thomas Plum / Freediving & Yoga:
